That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) for the natural flowage of waters over, upon and across the portion of Lot 194 designated as "Flowage Easement Granted Hereon," as granted and shown on the map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) for open space over Lot 194 and portions of Lots 7, 11 through 40, inclusive, 63 through 67, inclusive, 76, 77, 78, 83 through 85, inclusive, 87 through 106, inclusive and 189 through 193, inclusive, as granted and shown on the map and subject to the conditions set forth thereon.
