That said Council hereby accepts on behalf of The City of San Diego, the easement(s) for open space over Lot 1 and portions of Lots 2 through 31, inclusive, 105 through 117, inclusive, and 171 through 182, inclusive, as granted and shown on the map and subject to the conditions set forth thereon.
