- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
- That Resolution R-266446, adopted August 19, 1986, which authorized the sale of two parcels of City-owned property, being portions of Lots 1 and 2 of Section 17, Township 16 South, Range 1 West, S.B.B.M., to the City of La Mesa, be and the same is hereby rescinded.
