BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$32,200 from CIP No. 58-045, Sunset Cliffs Boulevard Bridge Bikeway Revenue Sharing Fund 18013, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
