1. That the City Manager is hereby authorized and empowered to execute, for an on behalf of said City, Change Order No. 21 to the Ingraham Street Bridge over Mission Bay Channel to barge demolition material to an artificial reef in City-owned waters west of Mission Beach under the terms and conditions set forth in the Change Order No. 21 on file in the office of the City Clerk as Document No. RR- 267113 .


2. That the City Auditor and Comptroller is hereby authorized to accept \$20,000 from the State of California, Department of Fish and Game.

3. That the City Auditor and Comptroller is hereby authorized to add \$20,000 to CIP No. 53-035, Ingraham Street Bridge over Mission Bay Channel.

4. That the expenditure of an amount not to exceed \$32,000 from CIP No. 53-035, Ingraham Street Bridge over Mission Bay Channel, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
