RESOLUTION NUMBER R- 267119

ADOPTED ON NOV 24 1986

WHEREAS, on March 4, 1985, the City Council authorized the City Manager to enter into a contract with the San Diego Regional Employment and Training Consortium (RETC) to allow the San Diego Regional Youth Employment Program (REGY) to operate a youth employment program known as "Career Start" for economically disadvantaged youths; and

WHEREAS, the original contract provided employment training and related services for 125 youths at a cost of \$287,500; and

WHEREAS, at the termination of that contract on June 30, 1986, the City had enrolled 147 youths while utilizing \$221,950; and

WHEREAS, RETC has made available \$80,500 to continue this program at a reduced funding level to March 31, 1987; and

WHEREAS, the revised program will enable REGY to serve 47 youths between the ages of 16 and 18 years old who are economically disadvantaged, school dropouts or graduates who function below the 10th grade level; and

WHEREAS, the program, through a plan that combines 320 hours of classroom and on-the-job and/or job training based on individual need, will attempt to place these youths in permanent employment situations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to

enter into an agreement with the San Diego Regional Employment Training Consortium, for the amount of \$80,500, allowing the City's Youth Employment Program (REGY) to continue to operate a Career Start Program to March 31, 1987, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-267119.
