RESOLUTION NUMBER R- 267136

ADOPTED ON NOV 25 1986

WHEREAS, the City Council of The City of San Diego authorized the Housing Commission to apply to the U.S. Department of Housing and Urban Development (HUD) for participation in the Housing Development Grant Program by Resolution Nos. 266233, 266234, 266235 and 266236, approved on July 15, 1986; and

WHEREAS, both SRO 100 and SRO 75, affordable residential hotel development proposals, were selected for funding by HUD; and


WHEREAS, pending changes to the Board of Commissioners of the San Diego Housing Commission could render the projects ineligible to receive the grant funding; and

WHEREAS, the San Diego Housing Commission has advertised for proposals for owner/developer/operators of SRO 100 and SRO 75 which would be eligible entities to substitute for participation subject to approval by HUD; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the actions taken by the Executive Director of the Housing Authority or his designee to solicit proposals from prospective owner/developer/operators are hereby ratified.

BE IT FURTHER RESOLVED, that the Executive Director or his designee is authorized to enter into exclusive negotiations with the selected owner/developer/operators.
