BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of street and storm drain easement deeds of OTAY MESA INDUSTRIAL GROUP and JET-AIR, INC., executed in favor of The City of San Diego, bearing dates of September 8, 1986 and September 17, 1986, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-267141-1 and RR-267141-2, granting to said City easements for public streets and drainage purposes in a portion of the Northwest Quarter of the Northwest Quarter of Section 36, Township 18 South, Range 1 West, San Bernardino Meridian, according to the Official Plat thereof, in the City of San Diego, County of San Diego, State of California, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for public streets, and the same are hereby named OTAY MESA ROAD and SANYO AVENUE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
