RESOLUTION NUMBER R- 267145

ADOPTED ON DEC 08 1986

WHEREAS, The San Diego County Water Authority has applied for a Section 404 Permit for the Pamo Reservoir Project from the United States Army Corps of Engineers to obtain such permit before June 15, 1987; and

WHEREAS, the Pamo Reservoir Project involves the construction of a dam at Pamo Valley north of Ramona, which will create a reservoir area capable of storing 130,000 acre feet of water; and

WHEREAS, San Diego City and County are in dire need of additional emergency storage facilities in order to minimize the effect of interruptions on its imported water supply and to alleviate shortages in dry years; and


WHEREAS, the Pamo Reservoir Project will not only supply such storage facilities, it will also capture in excess of 11,000 acre feet of water per year from local runoff and will generate hydroelectric power; and

WHEREAS, the Pamo Reservoir Project was selected after extensive geologic, engineering and environmental studies, and is sized and situated so as to benefit all water users within the Authority by making available, in time of need, an additional amount of water equal to over 25% of the total annual water demand within the Authority; and

WHEREAS, it is in the vital interests of the City of San Diego that the project be constructed and put into operation as the earliest possible date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it urges timely completion of the Environmental Impact Statement, support of the requisite mitigating measures, and gives its full and unqualified support to the issuance of a Section 404 Permit for the Pamo Reservoir Project by the United States Army Corps of Engineers prior to June 15, 1987.
