WHEREAS, Mr. Charles R. Cono and Mr. Gene C. Hanken of Hanken/Cono Incorporated want to donate two (2) pairs of night-vision goggles to the Police Department's Special Weapon and Tactic (SWAT) Team; and

WHEREAS, this equipment will be of great value in SWAT missions which must be carried out in darkness; and

WHEREAS, the goggles can be changed from a "starlite" to "infrared" mode with the flick of a switch and this feature makes them extremely useful in low-light situations such as night-time canyon searches and in situations where there is almost no light such as warehouse searches; and

WHEREAS, in addition to the enhancing night-time vision, this equipment enables officers to scout or gather information covertly in darkness and will improve planning for SWAT operations and increase the level of officer safety; and

WHEREAS, the total value of the contribution is \$12,000 for the two devices; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to accept, for and on behalf of said City, a donation of two (2) pair of night-vision goggles from Hanken/Cono Incorporated, for use by the Police Department's Special Weapon and Tactics Team.

BE IT FURTHER RESOLVED, that this Council, for and on behalf of the people of San Diego, does hereby extend this expression of gratitude to Mr. Charles R. Cono and Mr. Gene C. Hanken of Hanken/Cono Incorporated, for their very generous donation and display of civic responsibility.
