RESOLUTION NUMBER R- 267149

ADOPTED ON DEC 08 1986

WHEREAS, in late 1979, S & S Construction Company engaged the services of internationally known artist Bob Currie to create a mural for their sales office in the Presidio Place Condominiums project; and

WHEREAS, this large work of art, measuring 52x17 feet, is an impressionistic view of San Diego, the focal point being the Serra Museum in Presidio Park; and

WHEREAS, in creating the mural, special care was taken so that the work could be removed from the wall and the mural can be removed and stored in four foot sections; and

WHEREAS, S & S Construction Company has offered the mural to the City as a gift of art; and

WHEREAS, the conditions of the gift are:

(1) The City accept the gift in calendar year 1986,

(2) The City maintain ownership for at least two years,

(3) S & S Construction Company will remove and store the mural,

(4) S & S Construction Company will install the mural some time in the future;

and


WHEREAS, a committee from the Public Arts Advisory Board (PAAB) has inspected the mural and on October 9, 1986, the PAAB voted to advise the City Council to accept the mural as a gift; and

WHEREAS, although no site has been selected to display the mural, the members of the PAAB feel the City should accept the gift for future use; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the generous gift by S & S Construction Company to the City of a mural measuring 52x17 feet be and the same is hereby accepted under the conditions set forth above.

BE IT FURTHER RESOLVED, that this Council, for and on behalf of the people of San Diego, does hereby express its gratitude to S & S Construction Company for this generous gift of art.
