


RESOLUTION NUMBER R- 267170

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an amendment to the subdivision agreement for Golden Hills Villas, on file in the office of the City Clerk as Document No. RR-256183, to provide for the substitution of Carter Financial, Inc., for Golden Hills Villas, a limited partnership, as subdivider.

BE IT FURTHER RESOLVED, that Performance Bond No. 139273, issued by Insurance Company of the West, in the amount of \$248,609 is hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that Performance Bond No. 710631S issued by Developers Insurance Company, in the amount of \$235,846 is hereby released.
