



RESOLUTION NUMBER R- 267177
ADOPTED ON DEC 08 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of VILLAGE PROPERTIES, a general partnership, executed in favor of The City of San Diego, bearing date of October 1, 1986, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 267177, granting to said City an easement for public street purposes in a portion of Section 24, Township 14 South, Range 3 West, San Bernardino Meridian, and in a portion of Parcel 2 of Parcel Map No. 8042, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named EL CAMINO REAL.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
