WHEREAS, on November 17, 1986, the Rules Committee reviewed and approved three proposals regarding driver's license suspension notification by certified mail, local agency authority to promulgate minimum "living unit" requirements, and property tax exemption for certain nonprofit corporations acting in aid of government, as described in IRD Report No. 86-47, dated November 10, 1986; NOW, THEREFORE,
