
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with COUNTY OF SAN DIEGO, DEPARTMENT OF HEALTH SERVICES, DIVISION OF ENVIRONMENTAL PROTECTION, for household hazardous wastes, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 267196.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$303,550 within the Sewer Revenue Fund (41506) from Unallocated Reserve (70697) to Wastewater Engineering Program (70820).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$303,550 from Sewer Revenue Fund (41506), Wastewater Engineering Program, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project, and further authorizing the City Auditor and Comptroller to transfer unexpended funds to the appropriate reserves upon the advice of the administering department.
