

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF GUARDRAILS AND FLASHING BEACONS ON MT. ACADIA BOULEVARD AT SNEAD AVENUE AND MISSION CENTER ROAD NORTH OF SEVAN COURT, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on DEC 08 1986 and bearing official Document No. W.D. 118810 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF GUARDRAILS AND FLASHING BEACONS ON MT. ACADIA BOULEVARD AT SNEAD AVENUE AND MISSION CENTER ROAD NORTH OF SEVAN COURT.
4. That the City Manager and the City Auditor and Comptroller are directed and they are hereby authorized to add CIP No. 62-278 THE CONSTRUCTION OF GUARD RAILS AND FLASHING BEACONS ON MT. ACADIA BOULEVARD AT SNEAD AVENUE AND MISSION CENTER ROAD NORTH OF SEVAN COURT to the FY 1987 Capital Improvements Program.
5. That the City Auditor and Comptroller is hereby authorized to transfer \$89,500 from Capital Outlay Fund 30245, CIP No. 58-004 ANNUAL ALLOCATION - MISCELLANEOUS IMPROVEMENTS ON CITY STREETS to CIP No. 62-278 THE CONSTRUCTION OF GUARD RAILS AND FLASHING BEACONS ON MT. ACADIA BOULEVARD AT SNEAD AVENUE AND MISSION CENTER ROAD NORTH OF SEVAN COURT.
6. That the expenditure, not to exceed \$89,500 from Capital Outlay Fund 30245, CIP No. 62-278 THE CONSTRUCTION OF GUARD RAILS AND FLASHING BEACONS ON MT. ACADIA BOULEVARD AT SNEAD AVENUE AND MISSION CENTER ROAD NORTH OF SEVAN COURT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
