RESOLUTION NUMBER R-267209

ADOPTED ON DECEMBER 8, 1986

WHEREAS, a sewage spill occurred on November 27, 1986 in the Pump Station 64 service area; and

WHEREAS, pursuant to Ordinance No. 16695 the City Manager ordered a cessation of issuance of building permits in the Pump Station 64 service area; and

WHEREAS, under said Ordinance the cessation of building permits is required to be in place until the City Council after a public hearing shall continue or terminate the City Manager's action; and

WHEREAS, the City Council conducted the required public hearing on the cause and duration of the sewage spill of November 27, 1986; NOW, THEREFORE,

BE IT RESOLVED, that the City Council after considering the report of the City Manager and hearing and considering testimony from members of the public directs the City Manager to authorize resumption of the issuance of building permits in the Pump Station 64 service area.
