

RESOLUTION NUMBER R- 267215
ADOPTED ON DEC 08 1986
APPROVING MAP OF SITE 132.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Richard Eugene Gaddy, Licensed Land Surveyor, entitled "SITE 132 being a subdivision of a portion of the west half of Section 26 and of the east half of Section 27, all being in Township 18 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to official plat thereof, together with a portion of Coronado Avenue, Beyer Boulevard and Beyer Way as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Camino Donaire, Camino Aleta, Camino Alteza, Camino Ternura, Camino Regalado, a portion of Coronado Avenue, a portion of Beyer Boulevard, and a portion of Beyer Way, and said street(s) and portion(s) of street(s) are hereby declared to be public street(s) and portion(s) of public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


That said Council hereby accepts on behalf of The City of San Diego, the easement(s) listed in paragraphs 1 and 2 of the Owner's Certificate, as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) and portion(s) of street(s) are accepted on behalf of the public as heretofore stated; and those certain easements listed in paragraphs 1 and 2 of the Owner's Certificate, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
