- That the expenditure, not to exceed \$418,000 from CIP No. 5. 73-083 ANNUAL ALLOCATION - MAIN REPLACEMENTS; \$277,000 from CIP No. 44-001 ANNUAL ALLOCATION - MAIN REPLACEMENTS, and not to exceed \$1,029,535 from Capital Outlay Fund 30244 CIP 52-304 SORRENTO VALLEY ROAD - SORRENTO VALLEY BOULEVARD TO I-805 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
