ADOPTED ON DECEMBER 8, 1986

WHEREAS, a vacancy exists in the District 8 Councilmanic position by reason of resignation on November 12, 1986 of the past office holder; and

WHEREAS, section 12 of the Charter of The City of San Diego empowers the City Council to fill a vacancy occurring in the Council by appointment within thirty (30) days after the vacancy occurs; and

WHEREAS, the Council decided to pursue the appointment process and followed established procedures in pursuance thereof; and


WHEREAS, as a condition of said appointment, the Council required, and all applicants agreed, that whoever was ultimately selected would not be a candidate for said office at the next election thereof; and

WHEREAS, the Council conducted two public hearings on the matter and unanimously approved an appointment to said District 8 Councilmanic position for the remainder of such unexpired term to be served; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the provisions of section 12 of the Charter of The City of San Diego, Celia Ballesteros be and she is hereby

appointed to the position of Councilmember for Council District
8, to serve the remainder of the unexpired term of Uvaldo
Martinez, who has resigned.
