BE IT RESOLVED, by the Council of The City of San Diego, that a Consultant Review Committee be, and it is hereby established to be composed of representatives from the following:

Chamber of Commerce
Friends of the Library
Hillcrest Business Improvement Association
Uptown Community Planners
Representatives of the City Manager and Planning Director.

BE IT FURTHER RESOLVED, that each above-named agency shall name its own representative and, if necessary, an alternate to the Committee.

BE IT FURTHER RESOLVED, that the Committee will be chaired by a member of the City Planning Commission, to be appointed by the Chairperson of the City Planning Commission.
