APPROVING MAP OF CARMEL VALLEY INN.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Gerry Simon, Registered Civil Engineer, entitled "CARMEL VALLEY INN being a subdivision of all that portion of the North one half of Lot 1 of Section 30 Township 14 South Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey approved May 20, 1884, and that portion of the West 20 acres of Government Lot 4 (Southwest Quarter of the Southwest Quarter) of Section 19, Township 14 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, together with that portion of Carmel Valley Road (Road Survey 758) as dedicated to public use and a portion of Carmel Valley Road (Road Suvey 758) as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Carmel Valley Road, adjacent and contiguous to Lot 1, all as shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those certain abutters' rights of access, all as granted and shown on the map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
