
RESOLUTION NUMBER R- 267253

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of PARDEE CONSTRUCTION COMPANY, a California corporation, bearing date of July 18, 1986; storm drain easement deeds of PALOMAR ENTERPRISES, INCORPORATED, a California corporation, bearing date of August 13, 1986, and of PARDEE CONSTRUCTION COMPANY, a California corporation, bearing dates of August 27, 1986 and July 18, 1986, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-267253-1, RR-267253-2, RR-267253-3 and RR-267253-4, granting to said City easements for public street and storm drain purposes in portions of Sections 21 and 22, Township 14 South, Range 2 West, S.B.M., as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street and the same is hereby named POWAY ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
