
WHEREAS, the herein-described easement is being relocated and is, therefore, surplus to City needs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of the City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 267273, quitclaiming to DOROTHY BROWN PICKERING and PAUL P. PICKERING III, as trustees of the Pickering Trust No. 016598-00-04, all the City's right, title and interest in the sewer easement in Block 9, Fifth Street Addition, Map No. 577, as more particularly described in the quitclaim deed.

2. That the City Clerk of said City be, and he is hereby authorized and directed to cause the deed, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.


