RESOLUTION NUMBER R- 267276

ADOPTED ON DEC 15 1986

WHEREAS, the City Council in March 1985 unanimously approved a Minority and Women Business Enterprise Program; and

WHEREAS, businesses owned by minorities and women have traditionally received a disproportionately low number of contracts from government agencies; and

WHEREAS, the purpose of this Program is to increase the relative proportion of City contracts awarded to businesses owned and operated by minorities and women; and

WHEREAS, the San Diego Unified Port District will soon be soliciting and receiving bids for construction of a new convention center which will be operated by the City of San Diego; and

WHEREAS, the new Convention Center will be one of the largest governmental construction projects in the City's history and provides a unique situation to expand contracting opportunities for Minority and Women Business Enterprises; and


WHEREAS, the City's goals for construction contracts is to have 15% of the value of contracts awarded to Minority Business Enterprises and 5% to Women Business Enterprises; and

WHEREAS, a contractor who fails to meet these goals must demonstrate good faith efforts to contract with Minority and Women Business Enterprises or all bids will be rejected; and

WHEREAS, the City strongly encourages the Port District to put all prospective bidders on notice of the requirements of this Program and assist them to comply; NOW, THEREFORE,

BE IT RESOLVED, that the City Council strongly encourages the Port District to enforce the goals and intent of this Program for the Convention Center project.
