BOX OFFICE FEES¹

"Advance Ticket Sales": The charge for the advance sale of a reserve seat performance is ~~\$500~~ \$650 minimum against 5% of total gross ticket sales (whichever is greater) with a maximum of ~~\$750~~ \$900. For each additional performance, ~~\$375~~ \$500 will be charged.

The charge for the advance sale of general admission tickets for a single event date is ~~\$100~~ \$200 per week against 5% of total gross sales (whichever is greater) with a maximum of ~~\$750~~ \$900. For each additional consecutive event day, an additional ~~\$35~~ \$50 per week will be charged.

"Day of Event Sale": There will be a minimum charge of ~~\$75~~ \$175 for opening day sale, and a ~~\$50~~ \$150 charge for each succeeding day sale, when no advance ticket sales are handled through the Center Box Office.

COMMERCIAL SPACE

"Commercial Booth/Sale Space": When any facility of the Convention and Performing Arts Center is utilized for commercial sales, there shall be an additional charge levied of \$.10 per net square foot for run of show.

¹Upon implementation of the proposed rates, the day-of-event/performance box office manager will be provided by CPAC at no additional charge to the tenant. Currently, tenants reimburse CPAC for the cost of this individual's event hours.
