APPROVING THE APPLICATION AND AUTHORIZATION TO EXECUTE ASSOCIATED AGREEMENTS FOR HISTORIC PRESERVATION GRANTS-IN-AID FUNDS FOR THE CERTIFIED LOCAL GOVERNMENT GRANT PROGRAM.

WHEREAS, the Congress under Public Law 89-665 has authorized the establishment of a National Historic Preservation Grants-in-Aid Program, providing matching funds to the State of California and its political subdivisions for Certified Local Government Historic Preservation Program Grants; and

WHEREAS, the State Department of Parks and Recreation is responsible for the administration of the program within the State, setting up necessary rules and procedures governing application by local agencies under the program; and

WHEREAS, said adopted procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of applications and the availability of local matching funds prior to submission of said applications to the State; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Approves the filing of an application for the National Historic Preservation Grants-in-Aid assistance for the Certified Local Government Historic Preservation Program; and

2. Appoints and designates the City Manager of The City of San Diego, or his authorized deputy, to coordinate, process, and execute all contracts, agreements, amendments, and ancillary documents within the scope of the attached application; and

3. Agrees that all required local matching funds will be provided for the grant-funded program, if the 1988 Fiscal Year Budget for the Planning Department is adopted by the City Council with funds allocated for such purpose.
