APPROVING MAP OF ALTA DEL MAR P.R.D.  
UNIT NO. 1.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Gordon L. McElroy, Licensed Land Surveyor, entitled "ALTA DEL MAR P.R.D. UNIT NO. 1 being a subdivision of Parcel 2 of Parcel Map No. 15412 in the City of San Diego, County of San Diego, State of California, according to map thereof on file in the office of the County Recorder of San Diego County," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of general utility, sewer, drainage and water facilities, as granted and shown on the map within the subdivision.


That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across all of Lot 22 and those portions of Lots 1, 5, 6 and 7, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement(s) for open space, over, upon or across all of Lot 21 and portions of Lots 12, 13, 14 and 16 through 20, inclusive, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and the easement(s) with the right of ingress and egress for the construction and maintenance of water, sewer, drainage and general utility facilities, and the building restricted and open space easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of San Diego County, California.

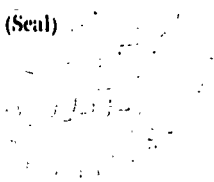
