APPROVING MAP OF MIRA ESTE BUSINESS PARK.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Guy W. Winton, Jr., Registered Civil Engineer, entitled "MIRA ESTE BUSINESS PARK being a subdivision of Parcel 2 of Parcel Map No. 14370, Parcel 3 of Parcel Map No. 13904, and the remainder parcel of Parcel Map No. 12044, together with Dowdy Drive as dedicated to public use, and a portion of Dowdy Drive as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Dowdy Drive, Silverton Avenue and Mira Este Court, and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across Parcel "A," as granted and shown on the map and subject to the conditions set forth thereon.



BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Dowdy Drive, approved by Council Resolution No. R-266784, on October 13, 1986, concurrently with the filing of the map.
