

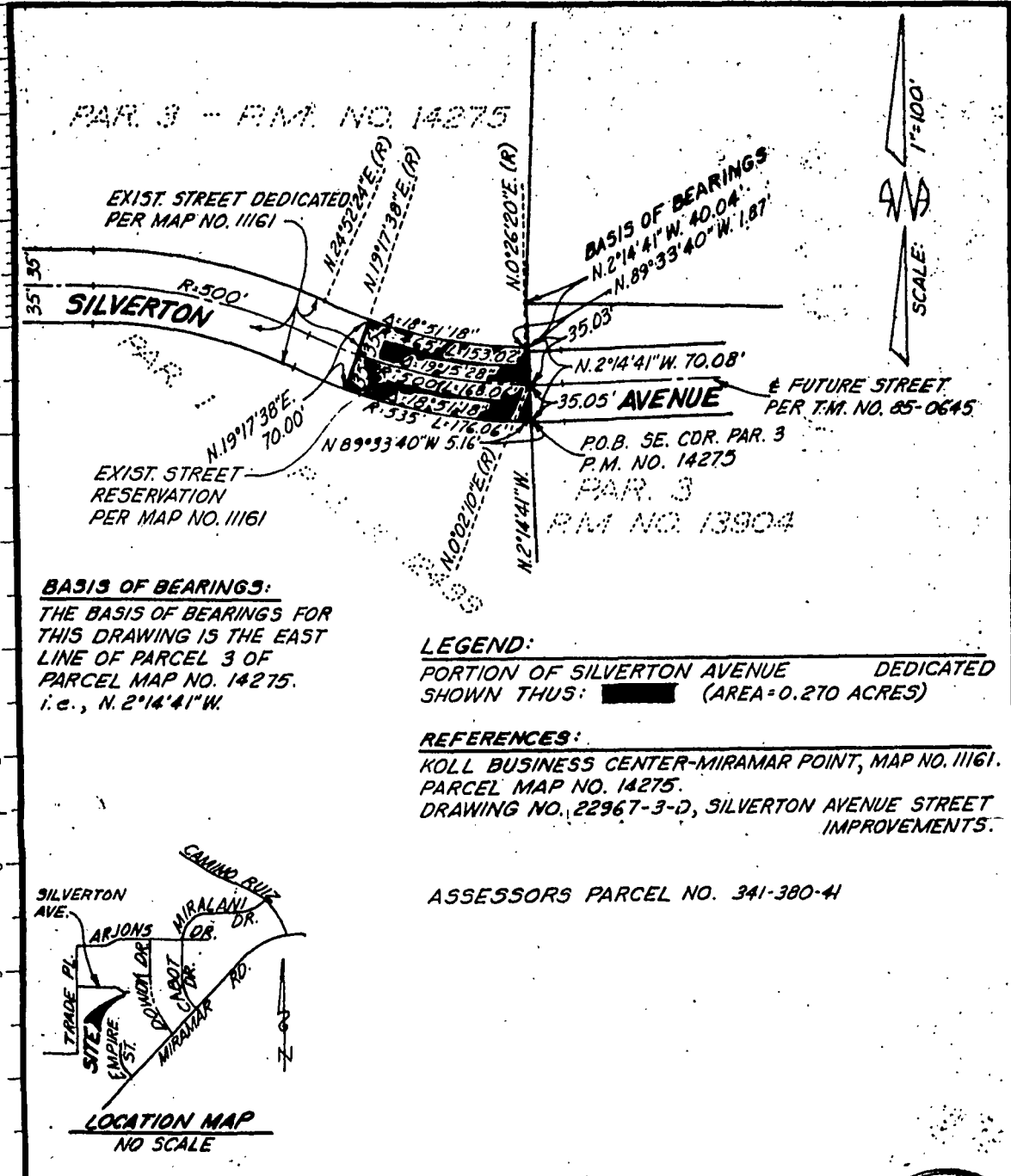

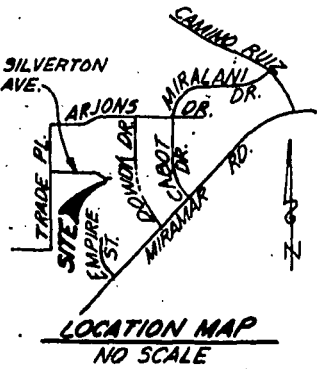


**BASIS OF BEARINGS:**

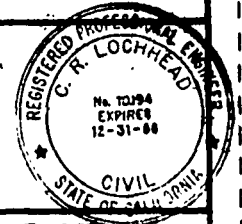
