
WHEREAS, the UNIVERSITY COMMUNITY PLANNING GROUP has submitted amendments to their bylaws as required by Council Policy 600-24; and

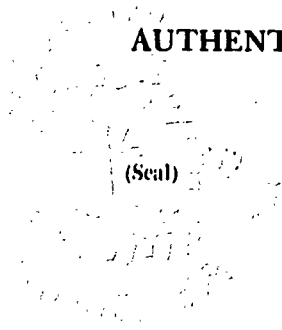
