Shevawn McGee	Attorneys	\$2,500.00	Ms. McGee was a Data Entry Operator at the time of this suggestion. She suggested indentifying cases with system numbers when raps are initially run. One year's experience has shown a savings of \$17,515.44 in time. This is the remainder of her award.
