Linda Logan	Attorneys	\$320.00	Ms. Logan is an Intermediate Typist. She suggested color coding the top edge of cards used for close out procedures. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Evelyn Leinen	Attorneys	\$280.00	Ms. Leinen is an Intermediate Typist. She suggested implementing an "OFFER" form that can be attached to an arrest report for court case. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Vicky Romero	Auditors	\$163.33	Ms. Romero is an Account Clerk. She suggested issuing Purchase Orders for consultant contracts instead of preparing Direct Payments. This has saved \$544.44 in time. This is her full award.
Mary Connolly	Attorneys	\$160.00	Ms. Connolly is an Intermediate Typist. She suggested using the word processor to type the signature paragraph on complaints instead of hand stamping. Although savings are difficult to identify, this is considered to be a significant operational improvement.
