John Coggins	Purchasing	\$ 45.00	Mr. Coggins is a Buyer. He suggested obtaining Personnel approval for requirements contracts at the time Purchasing prepares the resolution. Although savings are difficult to identify, this is considered to be a significant operational improvement.
