That the expenditure, not to exceed \$521,052 from CIP No. 73-234 LOWER OTAY FILTRATION PLANT EXPANSION to supplement funds previously authorized by Resolution No. 268313, adopted on May 11, 1987, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


