RESOLUTION ADOPTING AMENDMENTS TO THE GREATER
GOLDEN HILL COMMUNITY PLAN TO IMPLEMENT
SINGLE-FAMILY PROTECTION IN THE COMMUNITY.

WHEREAS, the proposed amendments to the Greater Golden Hill Community Plan would classify single-family areas in order to maintain them as single-family neighborhoods; and
