AN ORDINANCE SETTING ASIDE AND DEDICATING LOT 29 OF BILTMORE VALE, MAP NO. 8580; LOT 12 OF JAMESTOWN POINT, MAP NO. 8663; LOT 11 OF NOAH WAY POINT, MAP NO. 8664; AND PORTIONS OF PUEBLO LOTS 1243, 1244 AND 1246, MISCELLANEOUS MAP NO. 36, LOCATED IN THE NORTH CLAIREMONT AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "MARIAN BEAR MEMORIAL PARK."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 29 of Biltmore Vale, Map No. 8580; Lot 12 of Jamestown Point, Map No. 8663; Lot 11 of Noah Way Point, Map No. 8664; and portions of Pueblo Lots 1243, 1244 and 1246, Miscellaneous Map 36, which parcels are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Council of The City of San Diego hereby specifically reserves the right to establish underground public service easements through and across the dedicated property so long as the construction and maintenance of the subject easements do not substantially negatively impact the availability of the property for use for park and recreational purposes.

Section 3. That the hereinafter described real property be and the same is hereby named MARIAN BEAR MEMORIAL PARK.

Section 4. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

# LEGAL DESCRIPTIONS OF CITY-OWNED LAND BEING DEDICATED AS MARIAN BEAR MEMORIAL PARK

# Parcel 1

Lot 29 of Biltmore Vale, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 8580, filed in the Office of the County Recorder of San Diego County on May 20, 1977.

# Parcel 2

Lot 12 of Jamestown Point, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 8663 filed in the Office of the County Recorder of San Diego County on September 13, 1977.

# Parcel 3

Lot 11 of Noah Way Point, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 8664 filed in the Office of the County Recorder of San Diego County on September 13, 1977.

## Parcel 4

That portion of Pueblo Lot 1243 of Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof, a copy of which was filed in the Office of the County Recorder of San Diego County November 14, 1921 and is known as Miscellaneous Map 36, being described as follows:

Beginning at a point on the Easterly line of said Pueblo Lot 1243, being the Northeasterly corner of Clairemont Villas Unit 4, according to Map thereof No. 3228, filed in the Office of the County Recorder of San Diego County, Map 5, 1955; thence along the Northerly boundary of said Clairemont Villas Unit 4, North 89 15 07" West 467.14 feet to an angle point in the boundary of Clairemont Mesa North Unit 1, according to Map thereof No. 5103, filed in the Office of the County Recorder of San Diego County, December 28, 1962; thence along the boundary of said Clairemont Mesa North Unit 1, North 53°26'40" East 103.54 feet; thence North 8°11'53" East 119.22 feet; thence North 31°00'45" West 59.93 feet; thence North 44°43'25" East 202.21 feet; thence North 15°00'00" East 98.38 feet; thence North 18°01'37" West 101.32 feet; thence North 80°00'00" West 72.84 feet; thence North 70°00'00" West 52.90 feet: thence South 68°34'00" West 157.68 feet; thence North 85°21'05" West 143.75 feet to the most Southerly corner of Clairemont Mesa North Unit 2, according to Map thereof No. 5212, filed in the Office of the County Recorder of San Diego County, July 10, 1963; thence along the boundary of said Clairemont Mesa North Unit 2, North 43°48'33" East 259.34 feet; thence North 32°09'32" East 152.69 feet; thence South 83°00'00" East

69.01 feet; thence South 69°19'00" East 61.75 feet; thence North 89°18'12" East 92.94 feet; thence North 45°00'00" East 288.00 feet to an angle point in said boundary said point being on the Easterly line of said Pueblo Lot 1243; thence along said Easterly line, South 0°35'10" West 1,050.00 feet, more or less, to the Point of Beginning.

# Parcel 5

That portion of Pueblo Lot 1244 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map being filed in the Office of County Recorder of San Diego County, and is known as Miscellaneous Map 36, which lies Northerly of the South line of the North Half of the South 160 acres of said Pueblo Lot 1244.

Except therefrom the above-described portion of Pueblo Lot 1244, that portion thereof which lies Westerly of the Easterly line of the land described in deed to the San Diego Gas & Electric Company, recorded April 2, 1958 as File 52298 of Official Records.

Also except therefrom the above-described portion of said Pueblo Lot 1244, that portion thereof which lies Easterly of the location and prolongation of a line described as follows:

Beginning at the Southeasterly corner of said Pueblo Lot 1244; thence along the Easterly line of said Pueblo Lot, North 0°17'00" East 1,985.19 feet; thence parallel with the Westerly line of said Pueblo Lot, North 89°40'00" West 870 feet to the TRUE POINT OF BEGINNING: thence North 29°53'30" West 312.18 feet; thence North 37°10'00" West 245 feet; thence South 85°00'00" West 212.61 feet; thence North 23°00'00" West 347.59 feet; thence North 4°13'00" West 139.18 feet; thence South 89°53'00" East 119.00 feet; thence North 23°46'00" East 135.74 feet; thence North 36°34'53" West 173.19 feet to an intersection with the Northerly line of Pueblo Lot 1244.

Also excepting therefrom that portion which lies within University View Estates Unit 3, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5068, filed in the Office of the County Recorder of San Diego County.

## Parcel 6

That portion of Pueblo Lot 1244 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map being filed in the Office of County Recorder of San Diego County, is known as Miscellaneous Map 36, described as follows:

Beginning at the intersection of the Northerly line of said Pueblo Lot with the line shown on City of San Diego Operating Department Drawing 5265-L on file in the Office of the City Engineer and designated hereon "Shaw Line"; thence along said Northerly line South 75°18'30" West to an angle point in the Northeasterly boundary line of the land described in deed to Title Insurance and Trust Company, recorded January 15, 1959 under Document 9017 of Official Records; thence along said boundary line South 29°00'00" West, 240.00 feet; thence South 13°00'00" West, 216.42 feet; thence South 10°00'00" East, 315.54 feet; thence North 70°30'00" East, 284.06 feet; thence North 52°30'30" East, 542.66 feet; thence North 10°29'00" East, 110.00 feet; thence South 82°07'00" East, 170.81 feet to the line shown on City of San Diego Operating Department Drawing 5265-L on file in the Office of the City Engineer's and designated thereon "Shaw Line"; thence Northwesterly along said Shaw Line to the Point of Beginning.
