AN ORDINANCE AMENDING ORDINANCE NO. O-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16678-1 AND NO. OO-16678-2, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$689,660 FROM THE UNAPPROPRIATED FUND BALANCE OF THE SEWERAGE UTILITY REVENUE FUND (41506); AMENDING SECTION 2, SUBSECTION VI, ITEM 3, ENTITLED "SEWERAGE UTILITY REVENUE FUND (41506)" TO INCREASE NON-PERSONNEL EXPENSE AND TOTAL BY SAID \$689,660; AND DIRECTING THE AUDITOR AND COMPTROLLER TO SET ASIDE, TRANSFER AND ALLOCATE THE \$689,660 APPROPRIATED ABOVE TO THE SEWER ENGINEERING PROGRAM (70892), EAST MISSION BAY INTERCEPTOR CIP NO. 43-123.0.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, as amended and adopted therein, by transferring the sum of \$689,660 from the Unappropriated Fund Balance of the Sewerage Utility Revenue Fund (41506).

Section 2. That Section 2, Subsection VI, Item 3, entitled "Sewerage Utility Revenue Fund (41506)" is hereby amended to increase non-personnel expense and total by said \$689,660.

Section 3. That the Auditor and Comptroller is hereby directed to set aside, transfer and allocate the \$689,660 appropriated above to the Sewer Engineering Program (70892), East Mission Bay Interceptor CIP No. 43-123.0.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.


