ORDINANCE NUMBER O- 16797 (NEW SERIES)

ADOPTED ON JAN 26 1987

AN ORDINANCE INCORPORATING A PORTION OF THE NORTHEAST QUARTER OF SECTION 31, AND A PORTION OF THE NORTHWEST QUARTER OF SECTION 31, AND A PORTION OF THE NORTHWEST QUARTER OF SECTION 32, TOWNSHIP 14, SOUTH RANGE 2 WEST, SAN BERNARDINO MERIDIAN, LOCATED ON THE NORTH SIDE OF MIRA MESA BOULEVARD, BETWEEN INTERSTATE 15 AND BLACK MOUNTAIN ROAD, MIRA MESA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA AND R-3000 ZONES, AS DEFINED BY SECTIONS 101.0428 AND 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance a portion of the Northeast Quarter of the Northeast Quarter of Section 31, and a portion of the Northwest Quarter of the Northwest Quarter of Section 32, Township 14, South Range 2 West, San Bernardino Meridian, located on the North side of Mira Mesa Boulevard, between Interstate 15 and Black Mountain Road, Mira Mesa, in the City of San Diego, California, designated "CA and R-3000" on Zone Map Drawing No. B-3739.1, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0428 and

101.0409 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into CA and R-3000 Zones, as described and defined by Sections 101.0428 and 101.0429, the boundary of such zones to be as indicated on Zone Map Drawing No.B-3739.1, filed in the office of the City Clerk as Document No. 769460. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1. of this ordinance, Ordinance No. 10936 (New Series), adopted October 5, 1972, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
