ADOPTED ON JAN 27 1987

AN ORDINANCE AMENDING ORDINANCE NO. O-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16678-1 AND NO. OO-16678-2, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$411,700 FROM THE UNAPPROPRIATED FUND BALANCE OF THE SEWERAGE UTILITY REVENUE FUND (41506); AMENDING SECTION 2, SUBSECTION VI, ITEM 3, ENTITLED "SEWERAGE UTILITY REVENUE FUND (41506)" TO INCREASE NON-PERSONNEL EXPENSE AND TOTAL BY SAID \$411,700; AND DIRECTING THE AUDITOR AND COMPTROLLER TO SET ASIDE, TRANSFER, AND ALLOCATE THE \$411,700 APPROPRIATED ABOVE TO THE WASTEWATER OPERATION ENGINEERING PROGRAM (70820).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, as amended and adopted therein, by transferring the sum of \$411,700 from the Unappropriated Fund Balance of the Sewerage Utility Revenue Fund (41506).

Section 2. That Section 2, Subsection VI, Item 3, entitled "Sewerage Utility Revenue Fund (41506)" is hereby amended to increase non-personnel expense and total by said \$411,700.

Section 3. That the Auditor and Comptroller is hereby directed to set aside, transfer and allocate the \$411,700 appropriated above to the Wastewater Operation Engineering Program (70820).

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

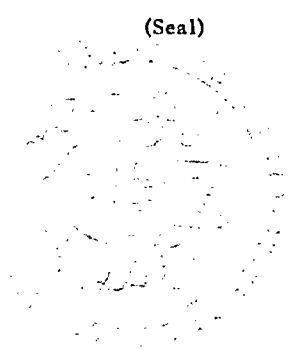


