AN ORDINANCE AMENDING ORDINANCE NO. 0-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16678-1 AND NO. 00-16678-2. AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$50,986 FROM THE GENERAL FUND 100, UNALLOCATED RESERVE (605) TO FUND 70229, ENTITLED "EASTGATE TECHNOLOGY PARK LANDSCAPE MAINTENANCE DISTRICT" AND APPROPRIATING THE SUM OF \$52,514 IN SAID FUND 70229 FOR THE PURPOSE FOR WHICH THE FUND WAS ESTABLISHED.

WHEREAS, the Eastgate Technology Park Landscape Maintenance District was formed after the passage of the FY 1987 Annual Appropriation Ordinance and therefore was not included in the ordinance; and

WHEREAS, this action will serve to appropriate funds for the district maintenance by transferring \$50,986 from the General Fund Unallocated Reserve; and

WHEREAS, most parcels in this district are owned by The City of San Diego and are available for sale; and

WHEREAS, until all parcels are sold, the City is liable for the assessment of \$49,216 and, in addition, the City is responsible for a half-year contribution of \$1,770 which represents a standard level of maintenance for the area, for a total City obligation of \$50,986; and

WHEREAS, other property owners in the district will be assessed \$1,528 for a total district budget of \$52,514; NOW, THEREFORE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, by transferring the sum of \$50,986 from the General Fund 100, Unallocated Reserve (605) to Fund 70229, entitled "Eastgate Technology Park Landscape Maintenance District."

Section 2. That the Auditor and Comptroller be and he is hereby authorized to appropriate the sum of \$52,514 in Fund 70229 for the purpose which said fund was established, as set forth in Council Resolution No. R-266166.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
