BE IT ORDAINED, by the Council of The City of San Diego, as follows:



Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings,

pursuant to the authority contained in sections 16, 17, and 71 of
the Charter of the City of San Diego.

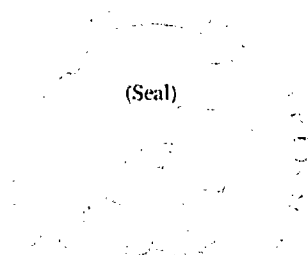
