ORDINANCE NUMBER O- 16806 (NEW SERIES)

ADOPTED ON FEB 9 1987

AN ORDINANCE INCORPORATING PORTIONS OF SECTION 12, TOWNSHIP 14 SOUTH, RANGE 3 WEST, S.B.B.M., LOCATED WEST OF TWIN TRAILS ROAD, NORTH OF CARMEL MOUNTAIN ROAD, AND SOUTH OF BLACK MOUNTAIN ROAD, IN THE PENASQUITOS EAST COMMUNITY, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-5000 (HR) ZONE, AS DEFINED BY SECTIONS 101.0407 AND 101.0454 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8858 (NEW SERIES), ADOPTED JULY 18, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance a portion of Section 12, Township 14 South, Range 3 West, S.B.B.M., located west of Twin Trails Road, north of Carmel Mountain Road, and south of Black Mountain Road, in the City of San Diego, California, designated R1-5000 (HR) on Zone Map Drawing No. B-3709.3, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0407 and 101.0454 shall attach and become applicable to the said subdivided land, and said subdivided land shall be incorporated into R1-5000 (HR) Zones, as described and defined by Sections 101.0407 and 101.0454, the

boundary of such zone to be as indicated on Zone Map Drawing No. B-3709.3, filed in the office of the City Clerk as Document No. ~~769485~~. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1. of this ordinance, Ordinance No. 8858 (New Series), adopted July 18, 1963, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
