ORDINANCE NUMBER 0- 16808 (NEW SERIES)

ADOPTED ON FEB 9 1987

AN ORDINANCE APPLYING THE COMMUNITY PLAN IMPLEMENTATION OVERLAY ZONE (CPIOZ) TYPE "A" TO THAT AREA OF THE UNIVERSITY COMMUNITY LYING NORTH OF THE AT&SF RAILROAD TRACKS AND TYPE "B" TO THE LA JOLLA VILLAGE INN PROPERTY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the area of the University Community lying north of the AT&SF Railroad tracks generally bounded by the Pacific Ocean and La Jolla Community on the west, the Torrey Pines and Mira Mesa Communities on the north and east, and Interstate 805 on the east, in the City of San Diego, California, within the boundary of the district designated "Community Plan Implementation Overlay Zone Type A" on Zone Map Drawing No. C-725, filed in the office of the City Clerk as Document No. O-16808, be, and it is hereby incorporated into the Community Plan Implementation Overlay Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0457.

Section 2. The property described in Section 1 has been found by the City Council to meet Criterion A of Municipal Code Section 101.0457.2 and applications for development within the area shall be considered "Type A" applications.

Section 3. That Lot 1, Resubdivision 1, Villa La Jolla Unit 1, Map 6358 (the La Jolla Village Inn site) in the University Community Plan area, in the City of San Diego, California, within the boundary of the district designated "Community Plan Implementation Overlay Zone Type B" on Zone Map Drawing No. C-725, filed in the office of the City Clerk as Document No. 16808, be, and it is hereby incorporated into the Community Plan Implementation Overlay Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0457.

Section 4. The property described in Section 3 has been found by the City Council to meet Criteria B of Municipal Code Section 101.0457.2 and applications for development within the area shall be considered "Type B" applications.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.
