ORDINANCE NUMBER O- 16811 (NEW SERIES)

ADOPTED ON FEB 1 7 1987

AN ORDINANCE INCORPORATING THOSE COMMERCIAL ZONED AREAS BOUNDED ON THE NORTH BY THE SOUTHERN BOUNDARIES OF PARCELS ABUTTING ROBINSON STREET, ON THE SOUTH BY THE NORTHERN BOUNDARIES OF PARCELS ABUTTING PENNSYLVANIA AVENUE, AND THE PROPERTIES FRONTING ON FOURTH AND FIFTH AVENUES, IN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE PEDESTRIAN/COMMERCIAL OVERLAY ZONE AS DEFINED BY SECTION 101.0458 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That those commercial areas bounded on the north by the southern boundaries of parcels abutting Robinson Street, on the south by the northern boundaries of parcels abutting Pennsylvania Avenue, and the properties fronting on Fourth and Fifth Avenues, in the Uptown Community Plan area, in the City of San Diego, California, within the boundary of the district designated "Pedestrian/Commercial Overlay Zone," on Zone Map Drawing No. C-722.3, filed in the office of the City Clerk as Document No. 16811, be, and they are hereby incorporated into the Pedestrian/Commercial Overlay Zone, as such zone is described and defined by Section 101.0458 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building

permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
