AN ORDINANCE INCORPORATING LOT A-225 AND THE SOUTHERLY 250 FEET OF LOT A-226, SAN YSIDRO ADDITION NO. 5, MAP 1405, LOCATED ON THE SOUTH SIDE OF THE VISTA LANE AND SOUTH VISTA AVENUE JUNCTION, SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3000 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 0-8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance Lot A-225 and the southerly 250 feet of Lot A-226, San Ysidro Addition No. 5, Map No. 1405, located on the south side of the Vista Lane and South Vista Avenue junction, in the San Ysidro Community Plan area, in the City of San Diego, California, designated "R-3000" on Zone Map Drawing No. B-3793, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0409 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into R-3000 Zone, as described and defined by

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1. of this ordinance, Ordinance No. 8028 (New Series), adopted December 18, 1958, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
