

ORDINANCE NUMBER O- 16820 (NEW SERIES)

ADOPTED ON MAR 2 1987

AN ORDINANCE INCORPORATING THE NORTHWEST CORNER OF SANTO ROAD AND CLAIREMONT MESA BOULEVARD, PARCEL 2 OF PARCEL MAP NO. 6960, LOCATED IN THE TIERRASANTA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CN ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0426, AND REPEALING ORDINANCE NO. 10285 (NEW SERIES), ADOPTED APRIL 23, 1970, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the northwest corner of Santo Road and Clairemont Mesa Boulevard, Parcel 2 of Parcel Map No. 6960, located in the Tierrasanta Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CN" on Zone Map Drawing No. B-3800.1, filed in the office of the City Clerk as Document No. ~~769495~~, be, and it is hereby incorporated into CN Zone, as such zone is described and defined by San Diego Municipal Code Section 101.0426.

Section 2. That Ordinance No. 10285 (New Series), adopted April 23, 1970, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this
