AN ORDINANCE INCORPORATING A PORTION OF RANCHO SAN BERNARDO, IN BOOK 2, PAGE 462 OF PATENTS, IN THE RANCHO BERNARDO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-5000 SMALL LOT OVERLAY ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0455, AND REPEALING ORDINANCE NO. 9827 (NEW SERIES), ADOPTED JUNE 20, 1968, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance a portion of Rancho San Bernardo, in Book 2, Page 462 of Patents, in the Rancho Bernardo Community Plan area, in the City of San Diego, California, designated "R1-5000 Small Lot Overlay" on Zone Map Drawing No. B-3731, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of San Diego Municipal Code Section 101.0455 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into R1-5000 Small Lot Overlay Zone, as described and defined by Section 101.0455, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3731, filed in the office

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
