ORDINANCE NUMBER 0- 16832 (New Series)

ADOPTED ON MAR 24 1987

AN ORDINANCE AMENDING ORDINANCE NO. 16649 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87" TO CREATE THE NEW POSITION OF ARJIS ADMINISTRATOR; AMENDING EXHIBIT B TO SAID ORDINANCE TO INCLUDE SAID POSITION IN THE POLICE CATEGORY; ESTABLISH A RATE OF PAY THEREFOR AT RATE NUMBER 25.3; INCORPORATING SAID POSITION IN GROUP F OF THE OVERTIME ELIGIBILITY RESOLUTION NO. R-265708 AS INELIGIBLE FOR OVERTIME.

WHEREAS, the Automated Regional Justice Information System (ARJIS) is a highly complex and comprehensive computer system which was developed to provide centralized criminal justice information to police agencies throughout the County and ARJIS is currently operated under a joint powers agreement between ten San Diego County law enforcement agencies and five ex-officio members; and

WHEREAS, for many years, a police lieutenant was responsible for administering this system, but to make more effective use of sworn personnel, the San Diego Police Department requested that this position be filled with a non-sworn classification; and

WHEREAS, since there is no existing class which encompasses the duties and responsibilities of this position, it is recommended that a new class of ARJIS Administrator be established; and

WHEREAS, based on the level of program administration and responsibility, it is recommended that the salary of this proposed new class be established at salary rate 25.3, \$3,079 to \$3,733 a month and it is also recommended that this class be placed in the "No Representation Unit" and be ineligible for overtime similar to other professional classifications in that unit; and

WHEREAS, it is now necessary to amend the annual salary ordinance to create said position and establish an appropriate rate of compensation therefor; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 16649 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87" be and the same is hereby further amended by creating and establishing the position of ARJIS Administrator in Class No. 1253 and placing it in the "No Representation Unit."

Section 2. That said Ordinance No. 16449 (New Series) be and it is hereby further amended to amend Exhibit B thereto so as to add to and reflect said position designation of ARJIS Administrator in the Police category.

Section 3. As a schedule of compensation for the position established and enumerated in sections 1 and 2 above, the position of ARJIS Administrator is hereby authorized at salary rate 25.3 with a salary range of \$3,079 through \$3,733 per month.

Section 4. That said newly established position of ARJIS Administrator is hereby incorporated in Group F of the Overtime Eligibility Resolution No. R-265708 as ineligible for any overtime.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

This ordinance amends to annual salary ordinance by amending Exhibit B thereto, to add a new position of ARJIS Administrator in the Police category and setting said new position at a salary rate of 25.3. The ordinance also incorporates the ARJIS Administrator position in Group F of the Overtime Eligibility Resolution, declaring it to be eligible for overtime. Finally, the ordinance places said position in the "No Representation Unit."


