AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 63.25.73 RELATING TO OVERNIGHT STORAGE OF VESSELS, BOATS AND TRAILERS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 3, of the San Diego Municipal Code be and the same is hereby amended by amending Section 63.25.73 to read as follows:

SECTION 63.25.73 OVERNIGHT STORAGE OF VESSELS, BOATS AND
TRAILERS PROHIBITED

- trailer on the beach on the west, north and east shoreline of Mission Bay Park between Santa Clara Point and the Ingraham Street Bridge between the hours of 10:00 p.m. to 7:00 a.m., except where permitted by the Park and Recreation Director at an authorized beach mooring bar or facility. This prohibition shall not apply between 10:00 p.m. Friday night through 7:00 a.m. Sunday morning, nor from 10:00 p.m. of the night preceding an official holiday of the City of San Diego through 7:00 a.m. on the day of the holiday.
- (b) The Park and Recreation Director may without notice remove any vessel, boat or trailer stored or left in violation of Section 63.25.73(a) and the cost of removal and storage may be

recovered by the City against any person responsible therefor through collection processes or proceedings in any court of competent jurisdiction.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
